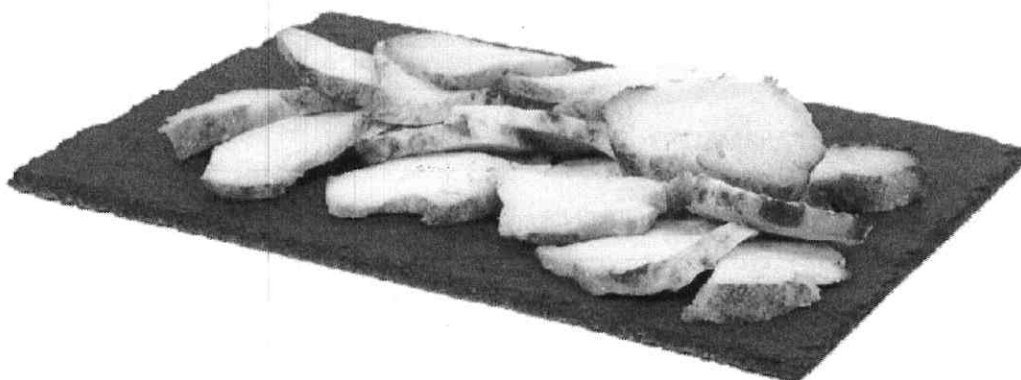

- free of any foreign smell;
- free of visible bloodstains;
- free of bones;*
- there shall be no traces of prior freezing.

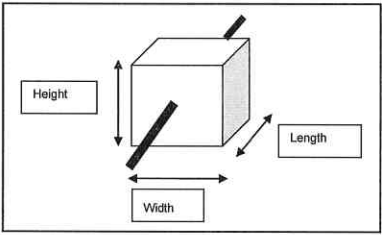
*Even though every effort has been taken to remove all bones, some may remain.

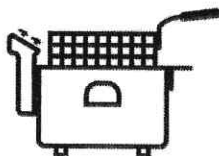
