

Description
Almonds biscuit filled with a rose cream, fresh raspberries and lychee. Frozen product.

Ingredients
raspberry 27%, sugar, BUTTER, ALMONDS 11%, EGG white, lychee 6.8%, whole MILK, EGG yolk, EGG white powder, modified starch, natural rose flavouring, colour (beetroot red: E162, carmine: E120), thickeners (xanthan gum: E145, guar gum: E412). May contain other tree nuts (hazelnurs, pecan nuts, pistachios)

Storage and instructions for use
Frozen product. 14 months at -18°C. Thaw 2 hours in the fridge (between 2 and 7°C) in the closed package. Store in the fridge (between 2 and 7°C) 5 days after thawing. Never refreeze a thawed product.
