Test report <u>E19-18542 (25-07-2019)</u>, performed by an independent institute, for global and specific migration of the finished product show compliance with this legislation.

Under the above conditions of use, the product complies with the legislation for global and specific migration (82/711/EEC, 85/572/EEC) on all substances mentioned in annex I (monomers, starting substances, macromolecules obtained from microbial fermentation, additives and polymer production aids) of the regulation 10/2011/EC.

No dual use additives were used in the manufacturing of this product. (as regulated by EC 1333/2008 and EC 1334/2008 and its amendments)
